#### THE OBJECTS OF THE TRUST SHALL BE:

- (a) To support and promote the advancement of education activities in all its branches from kinder garden upto college level institutions leading unto and teaching Diploma, degree post Graduate and Doctorate course in Arts, Science, Commerce, Engineering Medicine, Pharmacy, dental, Nursing, Nursery, Teachers Education, Management, Bio-technology, music and Fine arts, architecture and to impart industrial training and vocational training in the field of production and process, medical technology, science to develop other industrial activities and also such other subject as the Board of trustee may deem fit for the benefit of the people of all castes and communities, both from India and outside.
- (b) To enter into technical and financial arrangement with national and international agencies and institution for exchange of knowledge by study tours, training in specialized area of science & technology, conducting joint projects, providing technical assistance in the establishment of scientific institutions and for other matters consistent with the aims and objectives of the trust.
- (c) To make planning and development of Institutionalized Education in accordance with the directives given by the competent authorities of the Education Department, Director of Technical Education medical Educational and/or other Govt. depts.. Universities in Odisha/other state in India or abroad from time to time.
- (d) To establish libraries, reading rooms, audio-visual aid centers reference index libraries and any technical study facilities for the benefit of the local area.
- (e) To bring out, encourage and develop the inventive and research facilities of the pupils and teachers and to afford opportunity for research work in the field of science and engineering.
- (i) To establish, promote, setup and run educational institutions and to promote professional, technical, engineering and medical educational institutions in the state of Odisha through institutions and encouraging primary and secondary and higher education's also English Medium schools including training in handicrafts fine arts throughout the State of Odisha.
- (ii) To promote all means of educational research and training in urban and rural areas, based on contemporary social values and ethics as well as policies of the state and Nation and abroad and in accordance with the current and future sartorial needs of the nation
- (iii) To engage in assessing, formulating and implementing programs aimed at human resource development, with a specific focus on children, adolescents, and the youth.
- (iv) To work for the advancement of education, including academic, applied and vocational areas, through adoption of innovative stragegies based on findings of research and evaluative studies conducted by the trust as well as by other bodies including universities, autonomous research and academic institutions, and relevant and repute governmental non-governmental organizations in India and abroad.
- (v) To establish and run Vedic institutions, libraries, community centers and Research centers for the propagation and extension of ancient Vedic systems of India.
- (vi) To establish schools, colleges, institutions and training centers, coaching centers in choosing separate names and descriptions to meet special needs and requirements of the Trust in pursuance of the objectives of the Trust.
- (vii) To open and operate Technical and Professional Courses like Para Medical Courses like, Printing and Textile Technology and other computer based Diploma Courses nd Training Courses like Nursing, Pharmacy m Laboratory Technician, Distance and part Education Center etc.
- (viii) To undertake research projects for the academic needs of the Trust, or in connection with academic and vocational courses, both independently, and in collaboration with other academic and development institutions, as shall be deemed and essential in pursuance with the objectives of the Trust.
- (ix) To foster and encourage education and training in handicrafts fire arts, mong women folk in general and establish and found institutions imparting such education and to establish maintain support or help by monetary gifts or otherwise centers and institutions for women and children and to provide social welfare works for women and children.

#### THE OBJECTS OF THE TRUST SHALL BE(Cont...)

- X. To promote preservation of environment and ecology, promotion of human and animal health, human intervention towards regeneration of natural resources.
- XI. To organize and implement programs for rehabilitation and mainstreaming of persons in disadvantaged conditions and with disability, by setting up mentally retarded hospital and to support their ventures in self-employed and enterprising activities through extension education of vocational nature and aimed at their capacity building and empowerment.
- XII. The investment of the funds of the Trust/ Society / Association/ Institution shall be in accordance with the provision of Section 13(1)(d) read with section 11(5)of the I.T Act, 1961.
- XIII. The Trust Deed/ Memorandum of Association / Rules to the effect that the income of funds of the Trust / Society / Association / Institution shall be solely utilized for furtherance of the objects of the Trusty and no part of it shall be distributed among the members of the Trust / Society / Association / Institution by way of profit or dividend or otherwise.
- XIV. The Trust Deed / Memorandum of Association / Rules to the effect that in the event of dissolution of the Trust / Society / Association / Institution having similar objects and registered with the Commissioner of Income-tax under section 12AA and under section 80G of I.T. Act, 1961 where none of the trustees of the dissolved shall have controlling interest.
- XV. The benefits of the Trust / Society/ Association / Institution are open to all irrespective of cast, community, religion etc.
- XVI. No amendment to the Trust Deed / Memorandum of the Association / Bye-Laws shall be Competent Authority under the Income Tax Act.

XVII. To establish institutions to impact physical training and yogic education.

- **PET OBJECTS:-**
  - (i) To publish and disseminate though research papers, books. Journals. Magazines compact discs, and through internet any information and or knowledge of academic nature, without violating the norms and ethics of Indian Trust, and in accordance with the laws of the state.
  - To undertake programs of disseminating or exchanging knowledge by conducting training programs, workshops, seminars, conferences, sponsored tours and related activities.
  - (iii) To initiate community and non-formal health education amongst the people so that they become aware of the field of health hazard and their own potentials in the direction of taking appropriate preventive primitive and curative health activities and thereby to evolve to health eared system which is effective, affordable, available and acceptable to the people in general
  - (iv) To assist and collaborate with other organizations having similar objectives; and to operationally projects/programs of human resource development and social change.
  - (v) To grant, pay or give scholarship, stipends, prizes, rewards, allowances and other financial assistance or help in cash or king to students with a view to help them in prosecuting their studies in schools, colleges, educational institutions teaching commercial and other arts including teaching of cultural arts or other training , research or educational works in India or abroad . In addition to publish Newspapers, Magazines, Journals etc
  - (vi) To meet travelling, boarding and lodging expenses for students going abroad for higher commercial and technical education.
  - (vii) Publishing research journals, books.
  - (viii) Conducting academic conferences, workshops, Seminar for scientific promotions.
